In the last six months of 2012, I have been engaged in the following activities:

- Continuing processing of inquiries made by creditors regarding claims transferred to the new bank
- Continuing processing of trustee's approvals/confirmations regarding transfers (e.g. in respect of leases and especially charges), including various investigations and correspondence by e-mail and telephone with the "applicants", (most often) (new) Roskilde Bank/FS Finans A/S
- Continuing responding to inquiries made by subordinated creditors and their agents
- Review of ruling made by the Court of Roskilde on 22 May 2012 regarding discovery of documents with the former Roskilde Bank (now FS Finans), cf. e-mail dated 19 June 2012 from the Public Prosecutor for Serious Economic Crime, and assessment and drafting of response to the Prosecutor's concurrent question regarding the duty of secrecy of a former employee of Roskilde Bank, cf. e-mail dated 20 June 2012.
